at orientation, or hats in support of environmental efforts are permitted. Please keep your uniform, including gloves, as clean as possible.

Each new employee will receive two uniform shirts upon hire. Uniforms are considered company property. Upon issue, company uniforms become the responsibility of the employee for maintenance and care. Company shirts should be washed with cool water and air dried. In the event a uniform needs repair or replacement, employees will be required to return the uniform. While normal wear and tear is expected, excessive damage or loss of company uniforms will require replacement at the employee's expense.

Green Steeze may issue new uniforms periodically or require uniforms to be returned for special purposes (e.g., logo change, corporate color change). Employees will be given notice of the exchange, and the company will provide suitable replacement uniforms.

Employees are required to return all issued uniforms upon termination of employment. If all issued uniforms are not returned, Green Steeze will deduct the cost of the uniforms from the employee's final paycheck.
